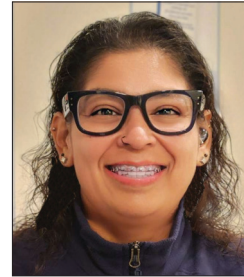

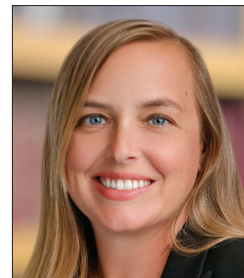

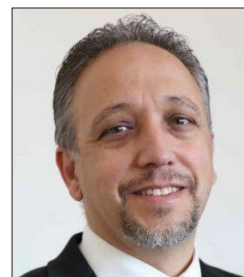


Kim Stratman, MSM, PMP
